## SECTION 4 – FIRST AID MEASURES

<b>SKIN:</b>	Remove contaminated clothing. Rinse skin with water for at least 15 minutes/shower. Consult a physician if irritation persists.
<b>EYES:</b>	Rinse cautiously with water for 15-20 minutes, keeping eyelids open. Remove contact lenses, if present and easy to do. Continue rinsing. Call a physician immediately.
